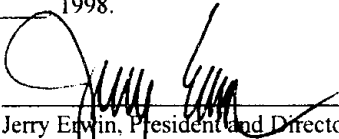
**AMENDMENT TO DECLARATION OF MOUNTAIN VIEW PARK
A Planned Community
(Declaration Amended Pursuant to ORS 94.590)**

Pursuant to a vote taken at the annual meeting of the Mountain View Park Homeowners Association on September 1, 1998, and in accordance with notice duly issued, section X(B) of the Declaration of Mountain View Park is hereby amended to read as follows:

No animals, livestock, or poultry of any kind, other than household pets, shall be kept or maintained on any part of any Lot. Dogs and cats, not to exceed a total of two (2) of each, may be kept on a Lot, provided that they are not kept, bred, or maintained for any commercial use or purpose, and are kept on a leash at all times when outside.

The above amendment to the Declaration of Mountain View Park was approved by an affirmative vote of the owners representing in excess of 75 percent of the total votes in the Mountain View Park Planned Community. With the exception of the foregoing, the Declaration of Mountain View Park remains unchanged.
