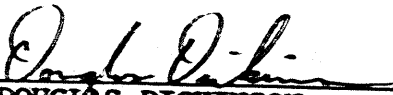

WHEREAS, there was a scrivener's error in the description of the section which was amended,

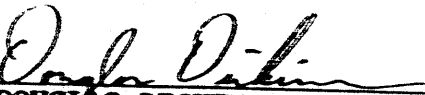
