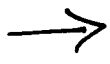

**AMENDMENT TO DECLARATION
OF
COVENANTS, CONDITIONS AND RESTRICTIONS
FOR
VILLAGE WIESTORIA HOMEOWNERS' ASSOCIATION**

Recorded by AmeriTitle as an accommodation only. No liability is accepted for the condition of title or for the validity, sufficiency, or effect of this document.

RECITAL:

- A. The original Declaration was recorded on May 23, 1997 in Deschutes County, Oregon, Volume 449, Page 1466-1501, Document Recording No. 97-18397.
- B. The Declaration was subsequently amended on March 19, 1999 in Deschutes County, Oregon, Volume 1999, Page 99-13688-1 through 99-13688-9.
- C. The homeowners signing below representing at least 75% of the total votes of each class of members eligible to vote hereby amend the Declaration of Covenants, Conditions and Restrictions for Village Wiestoria Homeowners' Association replacing the last paragraph of Section 4.1 so that it reads as follows:

AMENDMENTS:

Section 4.1, Page 7 - last paragraph is amended as follows:

Until the later of December 31, 2002 or when all Lots in Village Wiestoria have been conveyed to purchasers by the Declarant, including those Lots which may be annexed to the Association in the future, the Declarant may use the building constructed on Lot 32 for lawful purpose consistent with this Declaration. On or before such date, the Declarant shall convey Lot 32 to the Association as Common Area, subject to restrictions and easements of record and a mortgage or trust deed securing a promissory note in the amount of Two Hundred Six Thousand Five Hundred and No/100 Dollars (\$206,500.00) ~~securing a promissory note in the initial amount of not more than Two Hundred Thousand and No/100 Dollars (\$200,000.00) with an interest rate of not more than nine and one-half percent (9.5%) and an initial term and amortization of not less than twenty-five (25) years~~ with an interest rate of eight percent (8%) and an initial term and amortization of

not less than twenty (20) years.

THE REMAINDER OF THE DECLARATION, AS AMENDED, SHALL REMAIN IN FULL FORCE AND EFFECT.

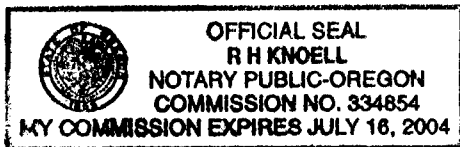
