AMENDMENT TO THE BUILDING AND USE RESTRICTIONS OF
WEST HILLS FIFTH ADDITION SUBDIVISION

The undersigned, Allan Bruckner and Bill Rooper, hereby certify that they obtained a list of the legal owners of lots in the Fifth Addition to the West Hills Subdivision in Bend, Deschutes County, Oregon and personally obtained the signatures of the lot owners contained in this Amendment. Allan Bruckner was an owner of a lot in the Fifth Addition to West Hills and Bill Rooper has purchased the Bruckner lot. It is the purpose of this document to amend the covenants, conditions and restrictions which currently attach to the lots in the West Hills Fifth Addition Subdivision as set forth below.

WHEREAS, West Hills, Inc., an Oregon corporation, heretofore and on the 25th day of March, 1958 at Book 118 Deeds, Page 455, recorded in the office of the County Clerk of Deschutes County, Oregon, certain Building and Use Restrictions, West Hills Subdivision, Deschutes County, Oregon (hereafter CC&Rs); and,

WHEREAS, these CC&Rs by reference in Deeds apply to the West Hills Fifth Addition lots; and,

WHEREAS, these CC&Rs allow in Paragraph 18 for changes in these CC&Rs "by vote of a majority of the then owners of the lots"; and,

WHEREAS, these C&Rs, in Paragraph 13, conflict with the original "Plat of Fifth Addition to West Hills", filed on the 25th day of May, 1970 with the County Clerk of Deschutes County, Oregon; and,

WHEREAS, it is the purpose of this amendment to correct the conflict in Paragraph 13, CC&Rs, as applied to the Fifth Addition to West Hills,

NOW, THEREFORE, the undersigned execute our signatures below as a vote in the affirmative to modify the aforementioned CC&Rs as follows:

The following paragraph shall be substituted in lieu of Paragraph 13 of the CC&Rs as recorded on March 25, 1958, Book 118 Deeds, Page 455 in the office of the County Clerk of Deschutes County, Oregon as applied to the West Hills Fifth Addition lots:

13. No residence shall be constructed on an area of land which is not at least 90 feet wide along the street frontage, excepting those originally platted on May 25, 1970 with less than such 90-foot frontage. All lots within the West Hills Fifth Addition as currently configured shall be deemed "buildable lots".

In all other respects, the CC&Rs as heretofore recorded shall remain in full force and effect.

By executing this document we authorize Allan Bruckner to record this document with the Clerk and Recorder of Deschutes County, Oregon if the requisite number of signatures needed to effect an amendment are obtained.

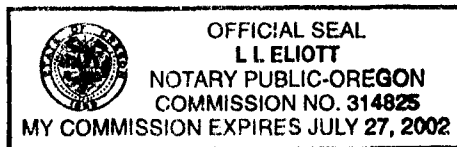
