

**AMENDMENT TO AMENDED PROTECTIVE COVENANTS
FOR WEST RIDGE SUBDIVISION**

1. Amended Protective Covenants for West Ridge Subdivision were recorded April 7, 1989 at Book 181, Page 2297 through Page 2318, Document Number 89-07767 and amended by Document Number 93-32210, Book _____, Page 0756, dated September 14, 1993.

2. The Covenants, as recorded, were not a complete statement of the Amended Protective Covenants for West Ridge Subdivision. Section 4 of Article IV was omitted. Article IV is entitled "General Provisions." Section 4 states:

"These covenants may be amended by a vote of 51% of the lot owners. Each lot owner is entitled to one vote regardless of the number of lots owned."

3. This addendum to the Amended Protective Covenants for West Ridge Subdivision is being recorded for the purpose of including Article IV, Section 4 in the Amended Protective Covenants for West Ridge Subdivision. From the date of this document, Article IV, Section 4 shall be a part of the Amended Protective Covenants for West Ridge Subdivision.

4. The undersigned are the members of the Architectural Control Committee as of April 7, 1989, and by their signatures state that Article IV, Section 4 was part of the Amended Protective Covenants and was omitted from the Amended Protective Covenants as filed. The undersigned state that Article IV, Section 4 was adopted by the appropriate number of lot owners of West Ridge Subdivision and is a part of the Covenants.

5. The owners of West Ridge Subdivision hereby amend the Amended Covenants as follows:

6. Article II, "Restrictions on Use of Property," Section 12 "Sale of Subdivision Sections" reads as follows:

"No sale of subdivided sections or tracts as platted is permitted unless approved by Deschutes County and the Architectural Control Committee."

7. Article II, Section 12 is replaced with the following:

"Each platted lot shall remain as originally platted. Subdivision or partition of lots is prohibited."

8. Article IV, General Provisions, Section 4, Amendment, currently reads as follows:

Return to: 1199 NW Wall
Bend OR 97701

"These covenants may be amended by a vote of 51% of the lot owners. Each lot owner is entitled to one vote regardless of the number of lots owned."

9. Article IV, General Provisions, Section 4, Amendment, is changed as follows:

"These covenants may be amended by a vote of 85% of the lot owners. Each lot owner is entitled to one vote regardless of the number of lots owned."
